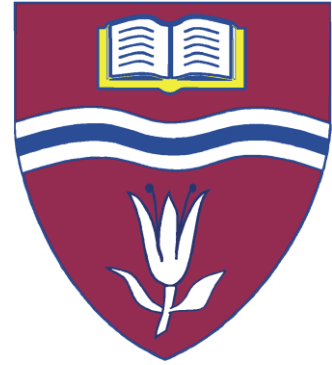

Vision

St Mary's CE (Aided) Primary School is a 'Christ-centred school with a child-centred curriculum' where wisdom and love guide and influence learning and teaching for our whole community. We treasure each child and enable them to flourish, using their God-given potential and establishing a secure foundation for them to thrive in a rapidly changing world.

Intent

St. Mary's aims to continue to provide an ambitious and broad curriculum in all subjects. We have extensive plans for the provision of remote education where needed and to ensure that the small number of children that need to be educated at home, for example, due to shielding or self-isolation, are given the support they need to continue learning.

Remote education, where needed, is of a high quality and aligns as closely as possible with in-school provision.

Implementation

In September 2020, all our classes returned to full-time education following the Covid-19 closure in March. Although we hope that the majority of our children will now have an uninterrupted experience, there is the possibility that an individual child, a class bubble, or indeed the whole school, will need to self-isolate for a period of time. We have therefore put in place a plan for remote learning so that all children can continue with their education. A Flexible Approach

Keeping regular learning going during the period that schools are closed is of great importance to reduce the impact on children's education, however we understand that everyone's circumstances at home will be different. Some families have one child to support while others have several. Some families have one device to share while others may have more – and some things may work differently on different devices. Some parents will have plenty of time to help their children learn, while others will be working from home and may have much less time and some children will be able to work more independently than others or need greater challenge.

Due to this we are providing a flexible approach to remote learning. We will offer a variety of weekly learning activities across the curriculum so that pupils can work their way through as much as they are able, at a time that suits them.

If a child does not have access to a computer/laptop and/or the internet, the school will do all it can to support children and if necessary provide paper packs of learning. Where funding can be accessed, remote devices (eg, laptops) and/or 4G connections will be sought, particularly for disadvantaged children. Parents will be reminded to make the school aware of any barriers to accessing remote learning.

Remote Learning Provision For Individuals Who Are Self-Isolating or Shielding

In the event that individual pupils are confirmed to be self-isolating or shielding due to COVID, class teachers will provide access to daily and weekly remote learning activities.

This will be shared via email and Google Classroom. This timetable will, as much as possible, link to our long-term curriculum plans and the learning those in school will be doing, while remaining manageable for staff to prepare on top of their usual weekly workload. To do this, we will make use of a number of pre-prepared high quality online materials (drawing heavily on units from the *National Oak Academy* that fit with our school curriculum) and supplement these with our existing subscription packages with which all pupils are familiar.

We appreciate that some families won't be able to engage with the full timetable, and in this case suggest they focus on key learning priorities to try to reduce the impact on children's core Maths and English skills. Staff will endeavour to view and feedback on as much of student's work as they are able (depending on their own situation), while balancing their workload inside of school.

Remote Learning Provision For Whole Classes

In the event that a whole class, Key Stage or whole school have to self-isolate, class teachers will post weekly timetables on Google Classroom for their class. This will outline a range of learning activities in the full range of subject areas and contain tasks and links to follow.

We appreciate that some families won't be able to engage with the full timetable, and in this case suggest they focus on key learning priorities to try to reduce the impact on children's core Maths and English skills.

Throughout the day, further posts may appear on Google Classroom which will add extra detail, support or examples as necessary and assignments will be set to 'collect in' a piece of work.

Other optional events and enrichment activity ideas will be spread throughout the week to help keep the children engaged and enthusiastic, as well as supporting their social interaction and physical and emotional wellbeing at this time.
